These Terms and Conditions of Membership will remain applicable to you as long as you access and use the features and services on www.halalasia.net and place Orders and/or Purchases on the platform. It is essential that you read and understand these Terms and Conditions of Membership, including any modifications made to them.

- 1.3. Halal Asia Network brings together brings together businesses and experts, fostering collaboration and providing a dynamic environment for members to access vital market insights, build impactful relationships, and navigate the ever-evolving landscape of halal certification and accreditation in Asia.
- 1.4. www.halalasia.net is an online news portal, developed as an extension of Halal Asia Network and owned by PT Halal Asia Network It is utilized to provide news content in the form of text, photos, audio, and videos to the members of Halal Asia Network.

2. DEFINITION

- 2.1. Network refers to www.halalasia.net.
- 2.2. Member refers to a user or member of Halal Asia Network who is entitled to access and obtain data and information available on www.halalasia.net
- 2.3. Buyer refers to individuals and/or legal entities (businesses) who purchase goods or services on the www.halalasia.net
- 2.4. Products refers to Items or services that are sold on the www.halalasia.net
- 2.5. Claim refers to the grievances raised by a Buyer due to the purchased Product being received in conditions, quality, or quantity different from the Sales Information.
- 2.6. Return refers to the process of product return initiated as a result of a claim made by one party against another.
- 2.7. Payment is a service in the e-commerce industry used by Halal Asia Network for authorizing payments through PayPal, Visa/Master/AMEX cards, and Bank Transfers.

3. APPLICATION AND ACCEPTANCE

- 3.1. Membership to join the Halal Asia Network is conditional upon confirmation of the application form and payment of a one-time joining fee.
- 3.2. The one-time joining fee is USD 900 (Nine Hundred US Dollars) and is non-refundable.
- 3.3. Prospective members should complete the application form available on the Network's website and submit it along with the joining fee. Payment can be made via PayPal, visa/master/AMEX cards, and Bank Transfer.
- 3.4. Membership will be activated upon receipt and clearance of the joining fee.

4. ANNUAL MEMBERSHIP FEE

- 4.1. All members are required to pay an annual membership fee to maintain their membership status.
- 4.2. The annual membership fee is USD 300 (Three Hundred US Dollars), payable at the beginning of each membership year.
- 4.3. The membership year starts on the date of acceptance into the Network and lasts one year.
- 4.4. If a member fails to pay the annual membership fee within 30 days of the due date, their membership may be suspended or terminated at the Network's discretion.

5. TAX

The prices of the products displayed on the www.halalasia.net website exclude a 11 percent Value Added Tax (VAT).
